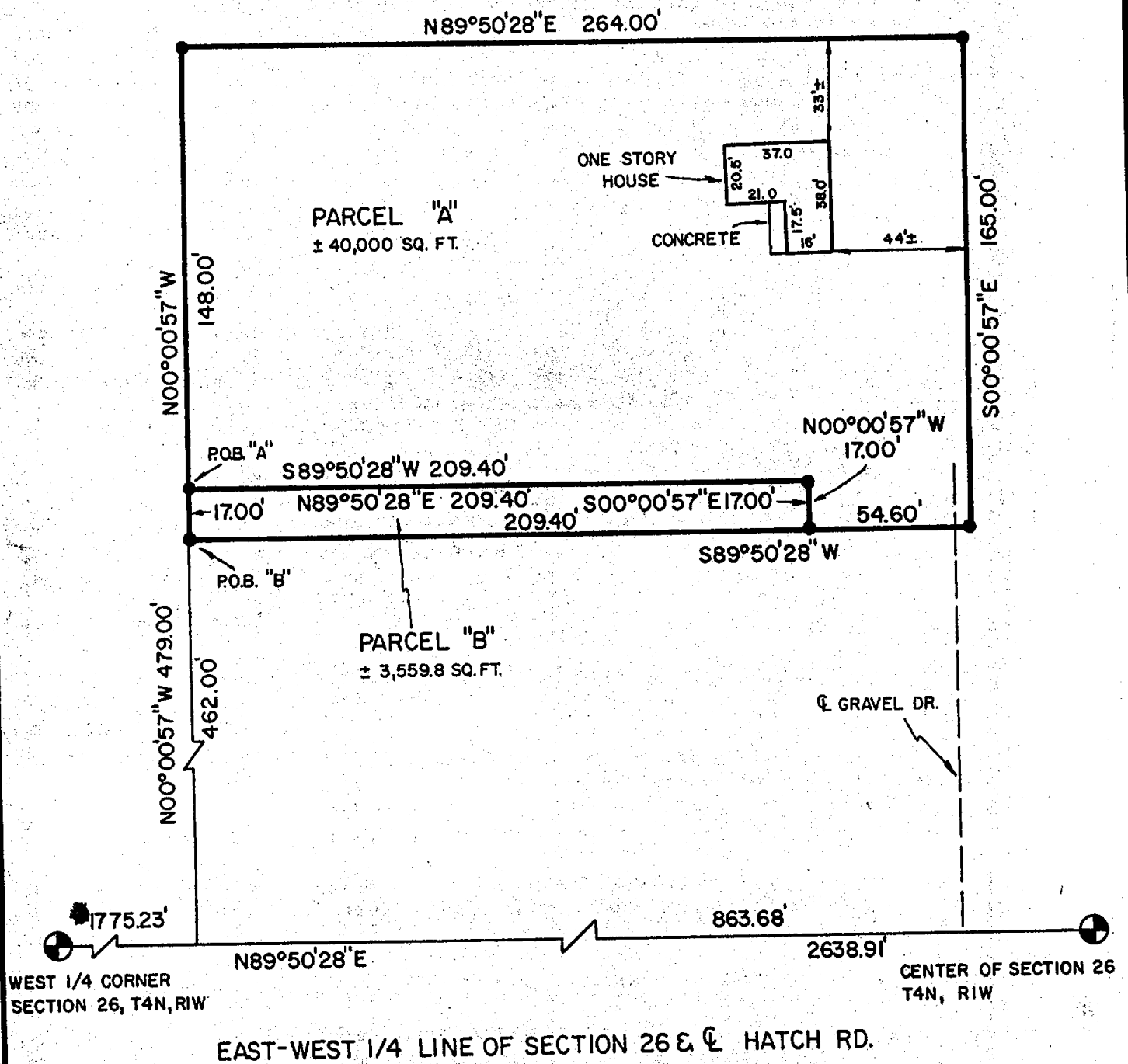

LEGAL DESCRIPTION: PARCEL A

A parcel of land in the Northwest 1/4 of Section 26, T4N, R1W, Meridian Township, Ingham County, Michigan; the surveyed boundary of said parcel being described by Michigan R.L.S. 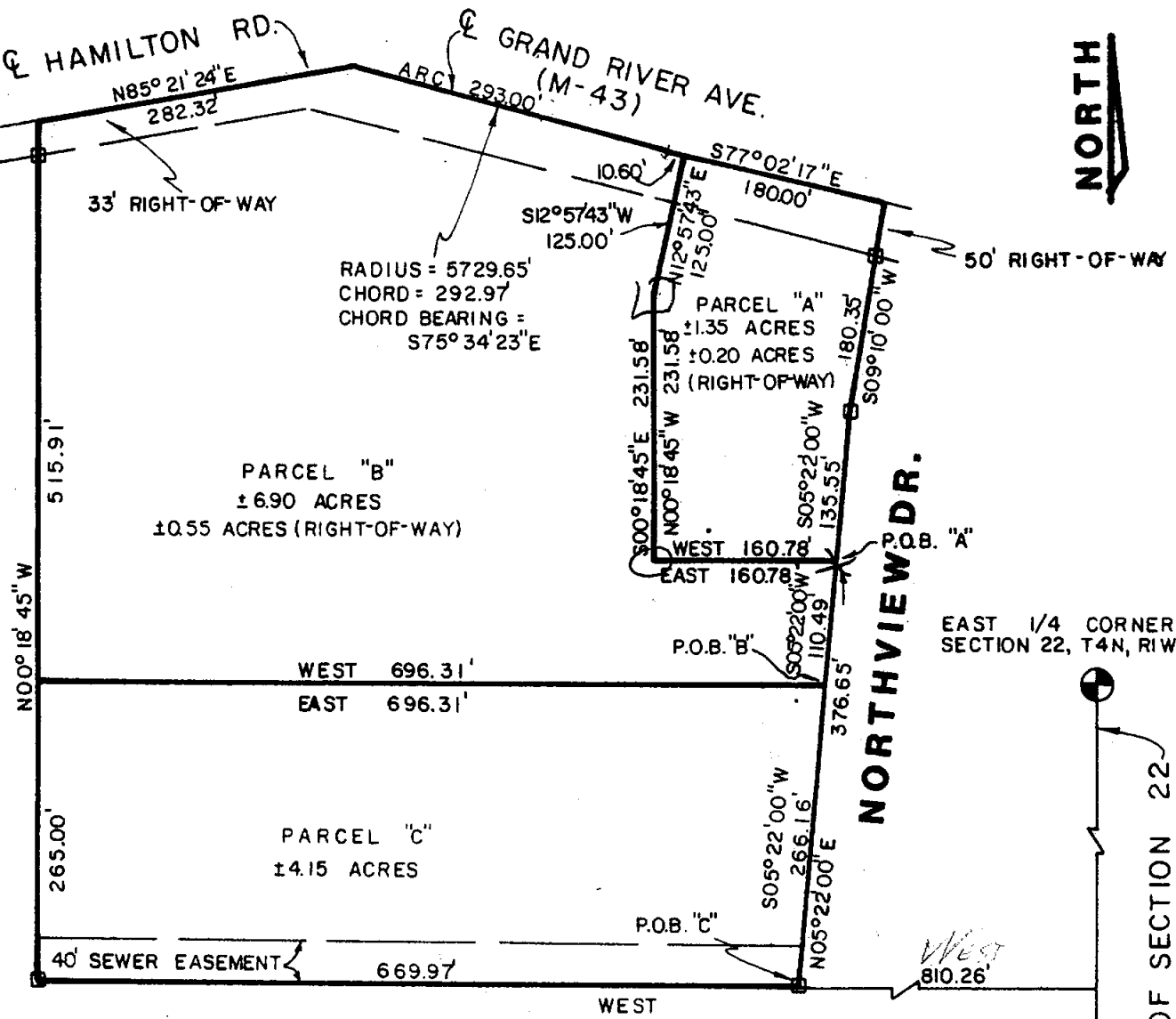
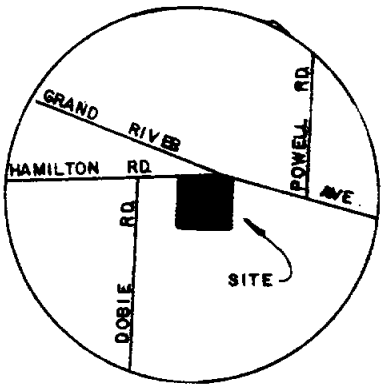

CERTIFIED BOUNDARY SURVEY

Parcel B:

A parcel of land in the Southeast 1/4 of Section 22, T4N, R1W, Meridian Township, Ingham County, Michigan; the surveyed boundary of said parcel described as commencing at the Southeast corner of said Section 22; thence N00°24'31"W along the East line of said Section 22 a distance of 1109.10 feet; thence West along the North line of Forest Hills Subdivision No. 2 and No. 3 a distance of 810.26 feet to the Westerly right of way line of North View Drive; thence N05°22'00"E along said Westerly right of way line 266.16 feet to the point of beginning of this description; thence West 696.31 feet; thence N00°18'45"W 515.91 feet to the centerline of Hamilton Road; thence N85°21'24"E along said centerline 282.32 feet to the centerline of Grand River Avenue (M-43); thence 293.00 feet along said centerline of Grand River Avenue along a curve to the left, said curve having a radius of 5729.65 feet and a chord of 292.97 feet bearing S75°34'23"E; thence S77°02'17"E continuing along said centerline of Grand River Avenue 10.60 feet; thence S12°57'43"W 125.00 feet; thence S00°18'45"E 231.58 feet; thence East 160.78 feet to said Westerly right of way line of North View Drive; thence S05°22'00"W along said right of way line 110.49 feet to the point of beginning; said parcel containing 6.90 acres more or less including 0.55 acre more or less presently in use as public right of way; said parcel subject to all easements and restrictions of record.

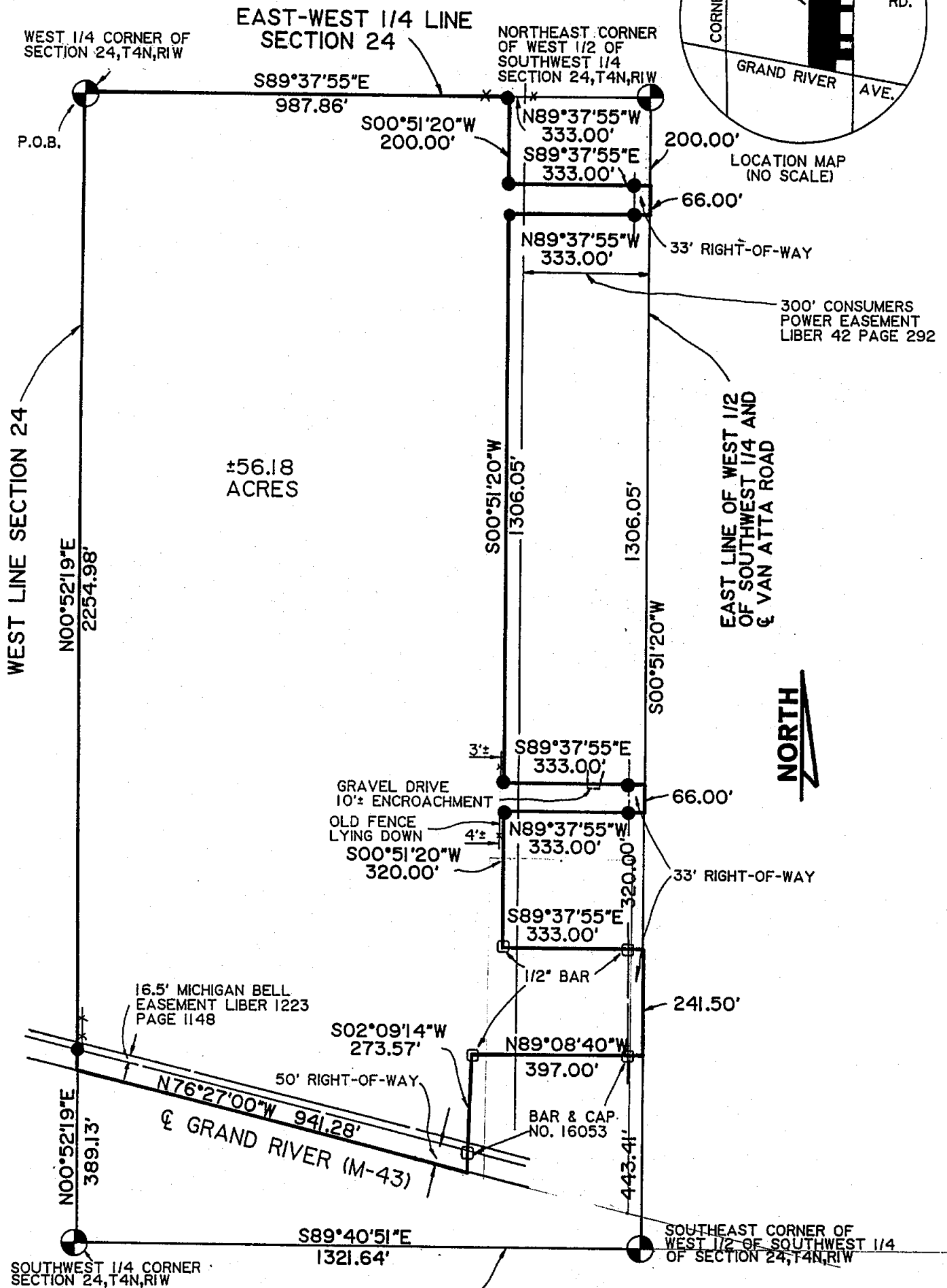
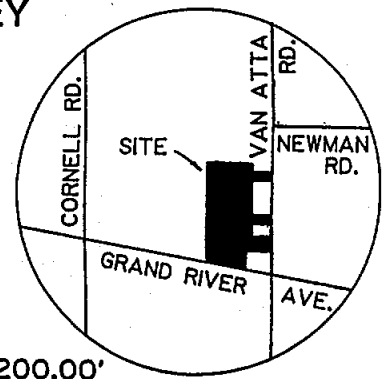
