After determining it to be lost, Deputy County Surveyor T. J. Brown re-established this corner in a survey dated January 15, 1869 and recorded in Volume 3, Page 44, County Surveyor's Records. "A post from which a 2" Apple bears N71-3/4°E 191 lks. and 8" Sugar S40-3/4°W 67-1/2 lks.

In a survey dated April 14, 1911 and recorded in Surveyors Record Volume 3 of County Surveyor's Records, R. J. Robb, County Surveyor, found a stone marking this corner witnessed by a Maple N.E. 49-1/2 lks. (39.27 ft.).

At measurement from Robb's bearing tree, dug hole in intersection of Columbia and Meech Roads. About 4 ft. below the surface, found stone with broken crockery around it.


