

RE: FIRST AMENDMENT TO ORDINANCE TO ESTABLISH A HOUSING COMMISSION

Adopted: January 22, 1980

Resolution No. 80-16

WHEREAS, Ingham County has established a housing commission pursuant to 1933 PA extra session 18 as amended, or ordinance adopted July 26, 1977, to provide for the conversion of the Ingham County Medical Care Facility into low income housing for the elderly, and

WHEREAS, the Board of Commissioners desires to provide additional powers and duties to the housing commission to provide additional low income housing by adding Article II(d) to said ordinance:

NOW THEREFORE BE IT RESOLVED that this Board of Commissioners adopt, and hereby does adopt, the First Amendment to the ordinance entitled "An ordinance to establish a housing commission, and specify its purpose, duties, authority and responsibilities, and specifically to provide for the establishment of low income housing for the elderly, pursuant to 1933 PA 18" adopted July 26, 1977, by adding paragraph II(d) attached hereto and entitled:

FIRST AMENDMENT TO AN ORDINANCE TO ESTABLISH A HOUSING COMMISSION AND SPECIFY ITS PURPOSES, DUTIES, AUTHORITY AND RESPONSIBILITIES AND SPECIFICALLY TO PROVIDE FOR THE ESTABLISHMENT OF LOW INCOME HOUSING FOR THE ELDERLY, PURSUANT TO 1933 PA EXTRA SESSION 18, AS AMENDED.

BE IT FURTHER RESOLVED that this ordinance amendment shall be engrossed by the County Clerk, shall be signed by the Chairperson and certified to by the County Clerk and transmitted immediately to the Governor by the County Clerk for the Governor's approval.

BE IT FURTHER RESOLVED that the County Clerk shall cause a copy of this ordinance amendment and notice of its adoption to be published once in a newspaper of general circulation in the County a minimum of fifteen (15) days prior to its effective date.

BE IT FURTHER RESOLVED that the County Clerk shall post this ordinance amendment in three (3) places in the County at least fifteen (15) days prior to its effective date.

FIRST AMENDMENT TO AN ORDINANCE TO ESTABLISH A HOUSING COMMISSION, AND SPECIFY ITS PURPOSES, DUTIES, AUTHORITIES, RESPONSIBILITIES AND SPECIFICALLY TO PROVIDE FOR THE ESTABLISHMENT OF LOW INCOME HOUSING FOR THE ELDERLY PURSUANT TO 1933 PA 18 EXTRA SESSION, AS AMENDED, AS ADOPTED JULY 26, 1977

The people of the County of Ingham, Michigan do ordain and add Article II(d):

ARTICLE II

(d) The Commission in cooperation with the County Board of Commissioners shall pursue additional subsidy units for the development of low income housing for the elderly within Ingham County. In all other respects the ordinance as originally adopted, July 26, 1977, shall remain in full force and effect.

This amendment shall be effective sixty (60) days after the date of its adoption.
